On successful completion of a Department for Transport approved course and SQA Examination, drivers will be issued with a Vocational Training (ADR) Licence by the SQA. Vocational certificates are valid for five years from date of issue.

Students undertaking refresher training should attend a course at least six weeks prior to the expiry of their existing vocational (ADR) certificate.

Class 2	Gases
Class 3	Flammable Liquids
Class 4	Flammable Solids
Class 5	Oxidising Agents, Organic Peroxides

Class 6	Toxic / Infectious
Class 7	Radioactives
Class 8	Corrosives
Class 9	Miscellaneous

Combination of above classes

EP Training offers any combination of the above classes dependent on the qualification required. For example:

Petrol tanker drivers require	Core, tanker and Class 3 (Flammable Liquids)
LPG tanker drivers require	Core, tanker and Class 2 (Gases)
Tanker & packaged goods drivers require	Core, tanker, packaged goods and all Classes (except 1 & 7)
Packaged goods drivers require	Core, packaged goods and all Classes (except 1 & 7)
Movement of explosives requires	Core and Class 1 (Explosives)
Movement of radioactives requires	Core and Class 7 (Radioactives)

Driver CPC

All existing Category C1, C and C+E drivers must undertake 35 hours Driver CPC Periodic training by every 5 years.

EP Training Services Ltd has developed various courses that will allow students to comply with the training requirements of both ADR and the Driver CPC Periodic at the same time.

The DVSA has approved 28 hours for ADR training Code CPC1 (Core, Pack, Tankers and Classes 1-9 Modules except 1 & 7), 21 hours for ADR training Code CPC 2 (Core, Pack and Classes 1-9 Modules except 1 & 7)

Once you have completed your 35 hours periodic training, you will be issued with a DCPQC (Driver CPC Qualification Card). This must be carried at all times whilst driving professionally.

Failure to produce your DCPQC can result in a fine of up to £1,000.

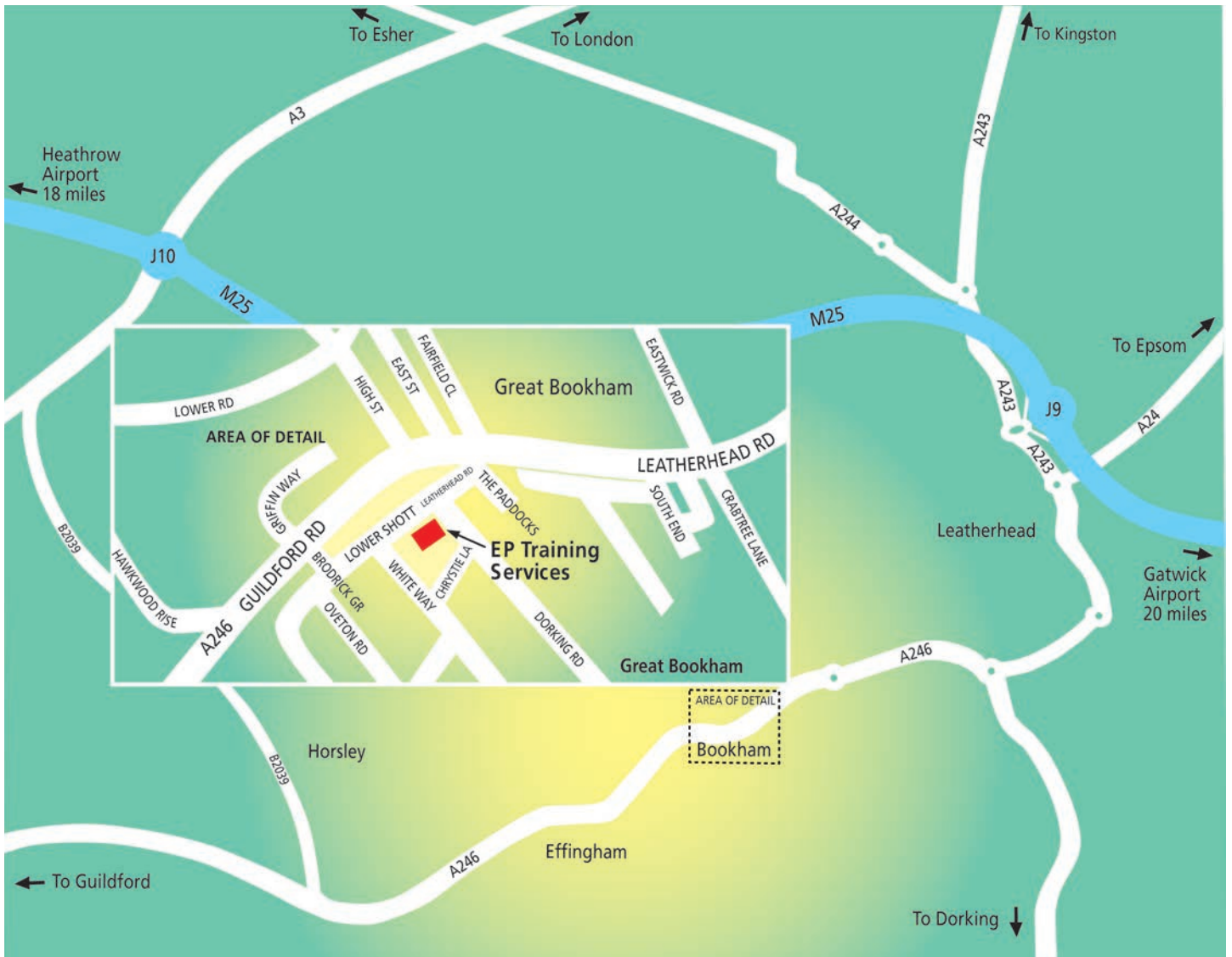
