Course syllabus

The syllabus is set by the Department for Transport, with examinations conducted by the Scottish Qualifications Authority. Our courses will cover the Core, Road and all UN Classes modules.



DGSA examination format

Courses conducted by EP Training will consist of the following:

Core Module, Road Module and All UN Classes Module

The Core paper will consist of ten compulsory questions of which:

- four will come from syllabus Group 1 topics
- four from Group 2 topics
- and two from Group 3 topics

The pass mark will be 65%.



Examination dates 2019

The DGSA examinations will be held nationally on:

7th March 2019
13th June 2019
12th September 2019
21st November 2019

Examinations should be booked directly through the Scottish Qualifications Authority (SQA) on 0845 279 1000. As examination places will be at a premium, it is advisable to book your examination as soon as possible (at least five weeks prior to examination date).

You should book the Core, Road and All UN Classes modules.

Course dates

Courses are conducted to coincide with the SQA examinations (see Course Dates).

Study material

As the examination is open book, candidates will need to take reference books into the examination. The SQA publishes a list of permitted examination material.

Candidates may purchase the relevant material from HMSO or Labeline, telephone 0870 850 5051 (our preferred supplier), prior to attending the course. A list of study material will be provided.



Course fees

Initial Intensive Courses 2019

The cost of the 5 day intensive course is £850.00 + VAT = £1020.00

The SQA combined examination and vocational certificate issue fee is payable direct to SQA. Their current fees are as follows:

£285.00	Three examinations on the same day
£210.00	Two examinations on the same day
£105.00	One examination

The necessary reference material will cost approximately £160. We will send you a list of SQA recommended study material with your course joining instructions.

Total cost for the course + exams + study material + VAT = £1,500.00.

We can book the exams for you and arrange for the permitted books to be sent to your home/company address.



Distance Learning Packs
